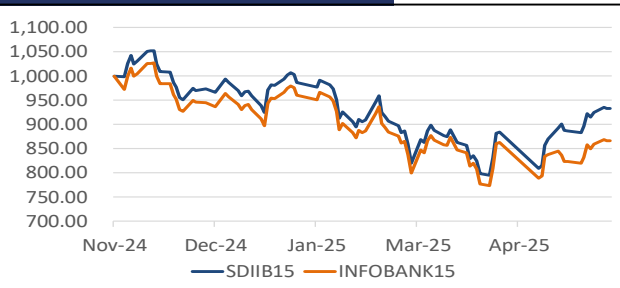

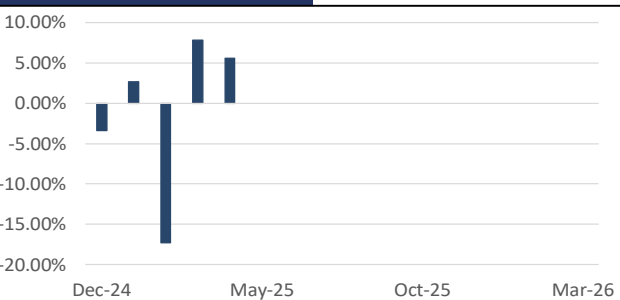
INFOBANK15 INDEX OVERVIEW
